



Planned Giving FAQs

What is a planned gift?

Planned giving is a way to make a thoughtful gift to your favorite charity or charities through financial or estate planning. Often these gifts may provide benefits like estate, capital gain, and income tax savings to the donors and their families, making these gifts even more attractive.

Why is a planned gift different from a gift I make with a check or cash?

Planned gifts typically involve some form of planning and financial advantage for the donor. Examples are outright gifts of assets like appreciated stock, real estate, or life insurance or gifts payable after a donor's death through wills, trusts, or retirement accounts. Donors often use a combination of outright and future gifts to maximize the impact of their support.

What's the first step in making a planned gift?

The first step is talking with one of our Philanthropy team about how you can help the children and families we serve now and in the future. With your interests and priorities in mind, we can then propose a variety of ways that you might structure your support. We will work with you and your financial and legal advisors about how to best make your planned gift come to life.

What is the easiest way to make a planned gift?

One of the easiest and savviest gifts you can make is listing Children's Home Society as one of the beneficiaries of your retirement account. It can usually be done online or with a simple form from your plan administrator. A retirement account gift can be of any size and importantly, may provide a significant tax savings for your estate and family after you are gone. Let us know if you'd like to learn more.

Child First Builds Strong Loving Family Relationships To Heal & Protect Young Children

Children's Home Society has been selected to implement the new and innovative Child First program, designed to improve childhood emotional health and increase learning success, initially in Mecklenburg County.

Child First is an evidence-based, intensive, early childhood model that works with the most challenged young children and their families, helping them heal from the damaging effects of stress and trauma.

"Child First has been identified by CHS as a key program demonstrating our commitment to keep children safely with their families whenever possible, a primary goal of our current strategic initiatives," said Rebecca Starnes, CHS Chief Program Officer. "Child First builds on our breadth of service offerings and provides significant opportunity for us to lay the groundwork for success with the program and future growth."

Child First supports young children (age zero through five) and their families in the home. Referrals come from both families and providers throughout the community system of care, including early care, education, pediatrics, early intervention, and child welfare.

"We are pleased to have been chosen to launch Child First in Mecklenburg County, and we are poised for further expansion statewide," Starnes added.


